The City of Pelham does not have a reduced rate for farm equipment or manufacturing equipment.

Automotive Rate includes new and used automotive vehicles, motorboats, truck trailers, semi-trailers, house trailers and mobile homes.

Rental Tax is due from the lessor on the total gross receipts from rentals of tangible personal property in Pelham.
